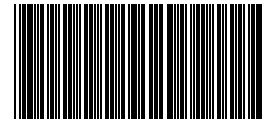

Summary of Class Action

This Class Action has been filed by Adam James Bray, father of Zachary Bray who was a victim in the fatal 11 June 2023 bus crash that occurred near the town of Greta in NSW. The lawsuit alleges misconduct or negligence on the part of the defendants, and individuals affected by the issues raised in the claim.

Who can join this Class Action

Anyone who has suffered damages or loss as a consequence of the crash.

This includes:

- i. persons directly injured, either physically and/or psychologically and/or psychiatrically, in the accident the subject of these proceedings ("accident") ("direct personal injury claimants");
- ii. persons suffering pure mental harm as a result of the accident, including what would be described in the former manner as "nervous shock claims" ("pure mental harm/nervous shock claimants"); and
- iii. persons able to rely on the compensation to relatives' legislation for loss of dependency as a result of the accident ("compensation to relatives claimants");

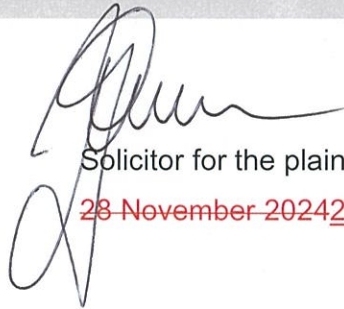
